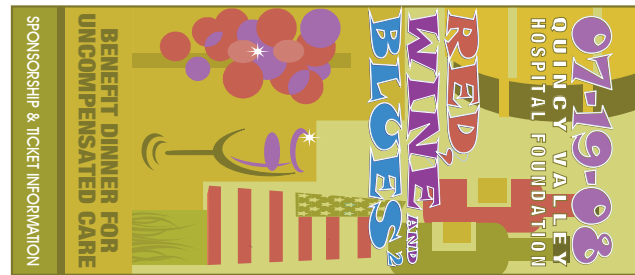

The purpose of the Quincy Valley Hospital Foundation is to financially augment Quincy Valley Medical Center. The Foundation helps purchase special capital equipment items and supports special projects. The Foundation only funds projects that will ultimately help the Medical Center fulfill its mission and vision. General operating expenses are not funded by the Foundation.

Over the years the Foundation has been involved with many projects. Most recently, the foundation granted the hospital \$50,000 for the following projects and equipment:

- + Electronic lifts for the long-term care residents.
- + Parking lot repairs.
- + Commercial laundry facility on campus.

The Foundation also raised \$75,000 to provide matching money for a USDA grant awarded to QVMC for the purchase of Computer Radiography (CR) equipment. CR provides better quality x-rays than the old equipment and allows for an expedited diagnosis.
